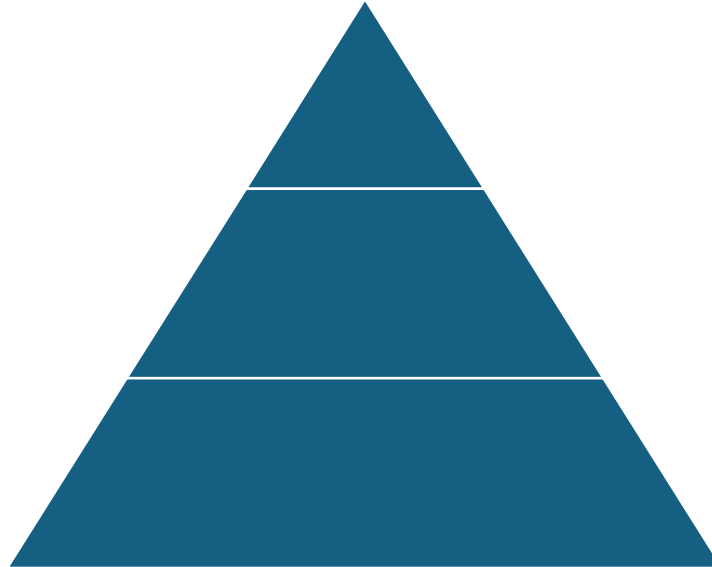

#### Background

My Name is Dennis Bruce Allums, a Licensed Real Estate Broker and a graduate of the University of California, Berkeley in the field of International Economics. For the past 35 years, I have been the leader of a Bay Area community patrol unit that spans the areas from Oakland to San Francisco where I am documented to have stopped/intervened in hundreds of crimes against women, children, the elderly, and the homeless beginning with the late 80's early 90's Larry Blakes sexual assault on two white U.C. Berkeley College Coeds; an event, in which I, as a black man, stopped the sexual assault but was forced to fight an entire block of African American males to prevent it. This was followed by numerous other heroic acts including but not limited to the 2008 sexual assault of a 12-year-old African American Berkeley High School freshman by a crazed white repeat sexual offender at the Shattuck Starbucks café, on Shattuck Ave, Berkeley,

California. Another heroic event in which I had to fight this crazed violent sexual offender who was clearly bigger and stronger than I was for over 10 minutes as the Berkeley police department did not or could not come. Their lack of response resulted in I being forced to fight him alone as the entire crowd at Starbucks refused to assist me. I eventually pinned the male to the ground as only one Berkeley police officer eventually arrived on his bike as if being called for stolen tea.

When he turned the suspect over and recognized the repeat violent offender he radioed for backup as suddenly over a dozen Berkeley police officers who could not respond to a child being sexually abused arrived to finally take the criminal from under me> Proof of how violent he was evidenced by them hog-tying him and placing a “silence of the lambs” head apparatus over his head as the 12-year-old victim and entire Starbucks crowd gasped in disbelief.

This brave act was followed by numerous other heroic acts culminating in the recent, 2023 physical assault of two more white U.C. Berkeley students by a screaming and deranged homeless African American male in which I intervened and protected numerous other women from thus why I was already following him before he truck again. Despite his threats to beat me over my head with the kings' donut sign I protected the two terrified students until the male ran away. I eventually hunted him down and published his image online with a full confession for all to see as the University of California, Berkeley has yet to do anything thus why I exist.

For over 35 years I am credited and documented with stopping over a thousand women, children and the elderly from harm even escorting one 80+ year old white female named Elizabeth for over five years as over five different males wanted to harm her. My record is beyond heroic as I don't even include my 2022 protection of 8 librarians at the Oakland public library against a knife-wielding crazed male, a heroic act that nearly resulted in my death as the suspect repeatedly attempted to stab me until I was forced to jump off a cliff to safety injuring both of my feet and ankles. My reward? Another dumb/corrupt police officer upon arriving pulled out his AR15 rifle instead of pointing it at the madman clearly sporting a knife, pointed at me, and almost shot me.

My record has been unblemished for 35 years until..... ECPD officer Edwin Jacala's racist self showed up and concluded that a black man who was stalked, followed, screamed at, and yelled racist remarks at, by another crazed homeless white male, so dangerous that El Cerrito city council member Greg Lyman wrote in his response to my complaint that he and ECPD were well aware of this dangerous male, even officer Jacala in his report states that he had several earlier encounters with the deranged man but since I extended my arms with open palms to stop the assault, this was clearly an assault by a black man on an innocent white man who was following, stalking and threatening me. He then immediately, referred me, the “dangerous black male”, to the district attorney as the true racist, violent offender who assaulted me and was allowed to harass numerous other El Cerrito residents. Something that could have been stopped if he charged the violent offender instead of the heroic victim.

Finally, let it be clear, ECPD's final act of abuse is the 4-year delay and lack of action against the white suspect in the December 31, 2019 event just referenced and the corresponding refusal to give me a copy of the video showing/proving ECPD officer Edwin Jacala's attempt to let off this violent racist and dangerous offender; all compounded by the 16 years of abuse as ECPD assisted individuals who repeatedly attempted to harm me, every time protected by the ECPD.

Again, I am a well-known hero of unmatched accomplishments over the last 35 years in protecting the entire Bay area. I also protect women worldwide evidenced as I am also the one who taught tens of thousands of women online how to defend themselves against stranger attacks spurred on by the attack, rape, and murder of an African American Youtuber in Virginia by a deranged white male (copy of my 24-hour lesson in self-defense is enclosed). I am known throughout America. Thus, why what your city and town have done to me is so shocking and will be viewed as such as the public learning what you have repeatedly done to one of the greatest heroes this world has ever known.

My name is Dennis Bruce Allums, an unmatched American, suspect to the ECPD.

I Therefore File.....

My Official Complaint instead of Suit 1 against the City of El Cerrito and the El Cerrito Police Department. (Time Is of the Essence)

#### Incident 1

In 2008, a racist madman speeding down the street, hit me in a crosswalk, jumped out, and then using a well-known martial arts strike, knocked me unconscious after stating "You people are so lazy". This occurred at the El Cerrito Plaza, in front of Starbucks café in front of dozens of terrified witnesses, Officer Alvarez took one look at me, the victim, and frowned and then proceeded to ignore me and all witnesses, waving them off as they tried to testify to what happened. The reasoning became obvious when I read the police report where he exaggerated/lie to get off a racist ladino who hit me with his SUV then struck me and knocked me unconscious. I wrote a detailed letter, enclosed, explaining the officer's bad racist judgment but declined to take legal action because as I stated then, I did not believe in suing my home police.

The incident was so bad that multiple witnesses came to file their support of me but I accepted only one, a witness whose last name was Gomez for he was of the same nationality and who wrote an elegant letter supporting me and my allegation.

#### Incident 2

On December 31 st, 2019

- A man followed me out of a drug store as I counted my money.
- Began cursing in my direction as he followed me.
- He or someone near him yelled racial epithets. I believe it to be he as I saw no one near me. He denies it.
- As I sped up he sped up he sped up also and continued to follow me
- As he closed in on me in the darkness of night, I repeatedly warned him not to come closer
- He ignored my request/order and continued to come closer

Unknowing to me he had closed the gap and was in front of some bushes as I reflexively extended my open palms legally in case he violated my safety zone.

- As I extended my arm his chest struck my open hands and fell back into the bushes I fled to the coffee shop and pondered calling the police as he had something in his hand that fell; t the ground.

I later learned that 1) Officer Jacala, according to his own words, had repeated complaints about the man and his unstable behavior 2) Multiple El Cerrito residents had been followed and harassed by him also as reports will show 3) Lucky's personnel as did other merchants knew who he was and they had repeated problems and he was banned from the lucky store.

YET,

Officer Jacal protected this dangerous lunatic and referred me, a black man, for charges. This is the second time the El Cerrito police department took the side of racist lunatic suspects and either helped them get off from major crimes or ignored their crimes altogether and referred me the obvious victim for prosecution by a cop who clearly shared what can only be considered racist views that endanger residents of El Cerrito of African descent.

In closing, it is called a Public records request so how is a video of me, which I intend to use to prove that the officer was wrong and the suspect is the victim and the victim is the suspect, his personal property? It was a camera paid for by the public and it is public property used while serving the public which means it is mine and other members of the public thus based on the definition of ..... your assertion that

“The department will not release any camera footage related to this incident as it is restricted from release per California Penal Code 832.7, California Government Code 7927.700, and ECPD Policy 803.5c.”

is wrong if not a totally biased fabrication and not representative of a good and honest police force nor is it evidence of good and honest police work.

### Incident 3

Today, 2/13/24, in you continued the racist abuse of me as I learned you denied my civil right and right to Officer Jacala's camera footage of his interview with me, the public property so subject to the rules of the public records request.

Incident 3 is viewed by me as the nearly 20-year continuation of harassment and racist policies beginning with the 2008 incident continuing with the 2019 incident and continuing as an officer I want under investigation for abusing my rights to exist free and unencumbered were violated when he submitted me for determination of prosecution by the D.A. despite overwhelming evidence to the fact that the criminal was the white male for all reasons stated. Your continued denial of the videos prevents the officer from being exposed to the public and denies me the right to take action

against the officer for his heinous behavior. Furthermore, the assertion that I have no right to a personal video made of me that shows inappropriate behavior by the officer due to the personal rights of the officer who is using a device pay for my taxes is insane. I, therefore, view the department's refusal to release video of the abuse of a resident of El Cerrito by police sworn to protect residents of El Cerrito as continued protection of the repeated racist and unprofessional/criminal action by the officers of the El Cerrito police department.

#### Incident 4

The totality of 16 years of continued abuse and violation of my civil rights to assist any race that violently abuses me as in 2008 or attempts to assault me as in 2019 culminating with your denial and hiding of video evidence of a possible corrupt officer video of him denying my civil rights and then refusing to give me a copy to possibly prosecute him for his heinous acts together is insurmountable evidence of a department gone bad.

I, therefore, file this complaint and request immediate action to remedy the 15 years of bad racist policing.

The following is a copy of your emailed denial of my right to see the video of Officer Jacalas action and my response to that denial.

Mr. Allums,

I received your letter/PRA request dated January 31, 2024 requesting the following:

1. "ECPD officer jcala's camera footage of his interview with me, suspect in a simple assault, December 31, 2019, at the el Cerrito plaza. Case 19-4070."

The department will not release any camera footage related to this incident as it is restricted from release per California Penal Code 832.7, California Government Code 7927.700, and ECPD Policy 803.5c.

2. "Officer Jacala's records including any complaints against him"

The department will not release any personnel records as it is restricted from release per California Penal Code 832.7, California Government Code 7927.700, and ECPD Policy 803.5c.

My response:

Section 832.7 - Peace officer or custodial officer **personnel records(a)** Except as provided in subdivision (b), the personnel records of peace officers and custodial officers and records maintained by a state or local agency pursuant to Section 832.5, or information obtained from these records, are confidential and shall not be disclosed in any criminal or civil proceeding except by discovery pursuant to Sections 1043 and 1046 of the Evidence Code. This section does not apply to investigations or proceedings concerning the conduct of peace officers or custodial officers, or an agency or department that employs those officers, conducted by a grand jury, a district attorney's office, the Attorney General's office, or the Commission on Peace Officer Standards and Training.
